Pursuant to article 59 and 62 of the Law No. 03/L-163, on Mines and Minerals and pursuant to article 5, article 6, article 7 paragraph 1.6, 3.1 and article 13 paragraph 1.16 of the Law No.04/L-161 on Safety and Health at Work, Regulation 06/2011 on Mining Safety, the Board of the Independent Commission for Mines and Minerals in the meeting held on 25.03.2016, hereby issues this:

ADMINISTRATIVE INSTRUCTION No. 05/2016

ON RULES OF PERSONAL PROTECTION EQUIPMENT AND OFFICIAL UNIFORM FOR FIELD OFFICIALS IN ICMM

Article 1 Purpose

- 1. ICMM with this Instruction aims at improving work conditions and improving the level of safety and health of employees at work, as it is foreseen by the Law No.04/L-161 on Safety and Health at Work
- 2. The purpose of this Instruction is to set rules by which are determined the standards and specifications of protection equipment at work and official uniforms for the ICMM officers performing duties in field and in the ICMM's office (according to Annex 1)

Article 2 Scope

- 1. By this Administrative Instruction are set rules for supply, usage and use of protection personal protection equipment and official (clothes) uniform, the standard of personal protection equipment and uniforms, forms and seasons of using, and punitive measures for the Field Officers of the Independent Commission for Mines and Minerals (ICMM).
- 2. This Administrative Instruction applies to all ICMM officers that the fieldwork is in the job description. Staff who may use the Official Uniform of field officers are:
 - 2.1.1 Member of the Governing Board
 - 2.1.2 Director
 - 2.1.3 Inspectors
 - 2.1.4 Geologists
 - 2.1.5 Surveyors
 - 2.1.6 Inspectors of Finance

Kuvendi i Kosovës Skupština Kosova Assembly of Kosovo 3. Any other member of ICMM who needs to perform certain representative duties for ICMM may be equipped with official uniform, representative uniform and personal protection equipment with decision of the ICMM Director.

Article 3 Definitions

- 1. Terms used in this Administrative Instruction have the following meanings:
 - 1.1.ICMM- means the Independent Commission for Mines and Minerals;
 - 1.2.Protection equipment are all equipment used for protection at work and which are indispensable for the work of field staff.
 - 1.3.Uniforms the meaning in this Administrative Instruction are the official field clothes, which have unique design and specifications differing inspectors and field officers of ICMM.
 - 1.4.Representative uniforms the meaning in this Administrative Instruction are the official clothes in cases of ICMM's presentation at different meetings and conferences within the country and abroad.
 - 1.5. Field Officers are all of the ICMM officers who work outside the ICMM offices and who due to their engagement and work they perform, they need to carry protection equipment and uniforms.
 - 1.6.Standard of protection equipment and uniforms presents a norm or requirement regarding the specifications of protection equipment and uniforms, and it presents a formal criterion.
 - 1.7.Purchase of equipment and uniforms —means the purchase and supply of ICMM with equipment and uniforms according to the requirements of this Instruction based on legal procedures regulated by law.
 - 1.8.Technical specifications presents all specifications of protection equipment for work and uniforms, including material, shape, standard, virtues and quality of products.

- 1.9.Hazard possibility that employees suffer injuries, illnesses or health difficulties, immediate or consequent, as a result of exposure to work environment containing hazardous physical, chemical and biological elements, exposure to working tools or machinery without protection equipment and unsafe to use, wrong way of using working tools and machinery and wrong way of work organization.
- 1.10. Punitive measures are verbal, written measures, remarks and disciplinary measures to be taken against any of ICMM officer who acts in violation of This Administrative Instruction.

Article 4 Standard of Protection equipment and Uniforms

- 1. Protection equipment and uniforms of official clothes which are ensured by the Administrative Instruction according to quality and destination shall respond to standards for use in mines and shall be in compliance with the provisions for security and safety at work by various risks appears.
- 2. It is allowed only the use of those protection equipment and uniforms official clothes which manufacturers, besides the instruction for use, prove by test that they are manufactured according to the standards and applicable provisions, by which the conditions which must be fulfilled are defined.
- 3. Protection equipment and Uniforms must have a certain period of use and that a term of at least 2 years and for this the contractor must submit the warranty related to the certain period of use.
- 4. If Protection equipment and Uniforms are damaged within 2 year period without the fault of user, then the contractor is obliged to change them with new equipment.
- 5. Exceptionally if protection equipment and uniforms of official clothes are damaged prior to the expiry of the term of norm, new protection equipment and new official uniform are given to personnel with the request of the responsible person of the department, and by final approval of the ICMM Director.
- 6. Form, design and colour of uniforms for field staff must be unique. Changing the form, colour or design is made only by decision of the ICMM Director.
- 6.1. Change can be made only after the expiry of use (two years).

Supply with Protection equipment and Uniforms

- 1. Supply with protection equipment and uniforms from the ICMM will be done every two years.
- 2. The procedure of purchase and supply shall be done by the applicable Law on Public Procurement.
- 3. Supplies with summer clothes shall be made at the latest in April of the respective year whereas with winter clothes no later than October.
- 4. This term can only change due to technical and procedural circumstances foreseen by the applicable Law on Public Procurement.

Article 6 Use

- 1. Protection equipment and uniforms shall be used only in the performance of duties and time related to working hours or also overtime works if this work schedule is approved by the Head of Department.
- 2. Giving to use the equipment and uniforms to other persons who are not ICMM employees is misuse and abuse of official duty, it violates this Administrative Instruction and is subject to punitive measures.

Article 7 Seasons of Use

- 1. Uniforms will be distinguished by seasons in summer and winter seasons and will be used in compliance with the seasons during the year.
- 2. The summer season begins in April and ends in October, while the winter season begins in October and ends in April. Adjusting the uniforms is done based on climatic conditions.

Article 8 Identification cards and vests

1. ICMM officers are obliged to keep identification cards of the ICMM visibly and in the upper part of uniform or to hang them around the neck during field work.

2. Identification cards must be in a frame of water resistant and scratch proof.

Article 10 Protection equipment and uniforms

- 1. Protection equipment and uniforms include:
- 1.1. Summer and winter shoes,
- 1.2. Summer/winter trousers.
- 1.3. Jackets Summer/Winter
- 1.4. Summer T-shirt,
- 1.5. Summer Shirt.
- 1.6. Rubber boots,
- 1.7. Protection helmet,
- 1.8. Eyeglasses,
- 1.9. Protection gloves,
- 1.10. Belt.
- 1.11. Bags for work
- 1.12. Reflective vest obligatory to dress in work-places.

Article 11 Specifications of Protection equipment and uniforms

- 1. ICMM shall comply with these specifications:
- 1.1. Summer and winter shoes (male/female): High-quality shoes. Elegant or field model with design that suit to uniform administration officials, to be comfortable for walking, model with or without shoelaces and to be standardized, waterproof and different oils proof, and to have internal lining. Deep winter shoes and frost and slips resistant.
- 1.2. Summer/winter trousers: Suitable and uniformed trousers, modern elegant of high quality, which can be cleaned and dried, material that retains its colour, which can be worn with waist belt.
- 1.3. Jacket Summer/Winter: high quality, waterproof and windproof, the design that suit to the uniformed administrative officers for the winter and summer season, deep isolated with lining. With sewing to put epaulets on shoulders, to be with fly zipper. Washable and dryable, material that retains its colour, resistant fly zipper with one-way or a two-way zipper on the front side,
- 1.4. Summer T-shirts: suitable for field work, shall have the ICMM logo.

- 1.5. Summer shirts: suitable for field work, shall have the ICMM logo.
- 1.6. **Rubber boots:** Boots must have two or more layers covered with protection measures in fingers and heel and sole should be made of two or more layers where one of them must be irony. Slip resistant, hit resistant and water penetration resistant. To have reflective signs in heel.
- 1.7. **Protection helmet:** Helmets shall be suitable, it shall contain a mechanism for setting the lamp and it shall be according to standards.
- 1.8. **Protection eyeglasses**: Eyeglasses shall not have dioptres. Eyeglasses shall be of two types transparent for underground mines or dark places and dark in surface mines where there are enough light.
- 1.9. **Protection gloves**: Gloves shall be made of cold proof and waterproof materials, to be suitable and elastic.
- 1.10. Waist belt: Shall be of strong material, attested to be suitable for work clothes.
- 1.11. Reflective Vest: shall have reflective colour, resistant to all other factors, such as scratches and Vests shall have the ICMM logo.
- 1.12. Bags for work: must be made of hard material with many pockets, water proof, are suitable to carry and have the size that meets the criteria and have spaces to carry the uniforms and other work tools.
- 2. Depending on the budget means in certain cases all the equipment cannot be purchased described in article 10 of this Administrative Instruction.

Article 12 Technical specifications of the uniform and field shoes

1. Field clothes shall be according to the attached technical specifications. Specifications may vary depending on ICMM requirements from year to year. Specifications for other field equipment will be prepared by the requirement unit at the time of the requirement for purchase. The colour of the uniforms shall be suitable and can be determined from year to year.

Article 13 Maintenance of Protection Equipment - Uniforms

1. Protection equipment and uniforms must be clean and in good condition.

2. Maintenance of protection equipment and uniforms shall be made by Officials who use them.

Article 14 Punitive Measures

- 1. Failure to use protection equipment and uniforms in field by officials determined by article 2 of the Instruction is considered a disciplinary violation.
- 2. Official is responsible for any change of standards uniform created based on this AI and it is considered a disciplinary violation.
- 2.1. Failure to respect the official uniform is considered a disciplinary violation and sanctions will apply for this.
- 3. Failure to respect this Instruction and official uniform is considered a disciplinary violation which will be prosecuted by the "Code of Conduct for Civil Servants No. 01/2006" and other applicable provisions.

Article 15 Transitional provisions

- 1. This Administrative Instruction shall enter into force 8 days after its publication in the Official Gazette of the Republic of Kosovo.
- 2. Upon the entry into force of this Administrative Instruction, it is abrogated the Administrative Instruction No.02/2010 ICMM dated 26.03.2010.
