Pursuant to article 7, article 54, article 59 paragraph 1 and article 62 of the Law no. 03/L-163 on Mines and Minerals and article 41, with articles 66A and 66B of the Law No. 04/L-158 on Amending and Supplementing the Law no. 03/L-163 on Mines and Minerals, the Board of the Independent Commission for Mines and Minerals in the meeting held on 03/03/2016 hereby issues this:

ADMINISTRATIVE INSTRUCTION (ICMM. AI. No. 03/2016) ON ADMINISTRATIVE FEES

Article 1 Purpose

- 1. The purpose of this Administrative Instruction is to determine all type of fees for persons applying for licenses or mining permits in ICMM, fees applying for their licensing, as well as fees for licensees.
- 2. ICMM shall ensure that any administrative fees will be in an amount that is reasonably calculated to compensate the ICMM for the administrative costs of processing the application or fulfilment of the applications, supervision, inspection and implementation of the license for its duration.

Article 2 Scope

1. This Administrative Instruction shall be implemented by ICMM and shall provide the method for determination and evaluation of fees and other administrative tariffs for submission, issuance of licenses or mining permits, and other fees (annual payment) that the licensees must pay for carrying out the activity licensed in compliance with Law no. 03/L-163 on Mines and Minerals (amended by Law No.04/L-158)

Article 3 Definitions

1. Terms used in this Administrative Instruction have the following meanings:

- 1.1. ICMM-means the Independent Commission for Mines and Minerals;
- 1.2. Licensee means the person or persons named and authorized by the license;
- 1.3. The initial administrative fee for issuance of a license or permit means the administrative fee to be paid by any person in order to issue a license or mining permit in ICMM.
- 1.4. The annual administrative fee- means the fee to be paid by the licensee annually for realization of the licensed activity.

Article 4 Administrative Fees

- 1. ICMM based on Law no.03/L-163 on Mines and Minerals (amended by Law No.04/L-158) is authorized to collect these types of payments in the administrative fees form:
 - 1.1. Administrative fees for submission and review of license applications, and their modification or change;
 - 1.2. The initial administrative fee for issuance of a license or mining permit;
 - 1.3. The annual administrative fees for realization of mining activity;
 - 1.4. Administrative fees for execution of monitoring, inspection activities, other services by ICMM.

Article 5

Administrative fees for submission and review of applications

- 1. The payment of this fee is made at the moment the application is submitted by the person applying for a license or permit in the ICMM, as defined by law.
- 2. This type of fee is required by the ICMM also for the requests for change or modification of licenses or permits.

Article 6

The initial administrative fee for issuance of a license or mining permit

1. This fee/initial payment is made for issuing or changing of the license/permit, expenses for preparations of license/permit and realization of activity regulation, maintenance until the end of the recent calendar year

2. This fee is paid at the moment the license or permit is issued.

Article 7

The annual administrative fee for issuance of a license or mining permit

- 1. The fee/annual payment for the realization of licensed activity is an annual fee to be paid by each licensee/permits holder after obtaining it.
- 2. The payment of this fee is made by the licensee in two forms:
- 2.1. At the beginning of each calendar year or;
- 2.2. Through monthly rates for which it is achieved the agreement with ICMM (agreement must be in writing and it is made by the requests of licensee)
- 3. The annual fee must be paid even when the license has been suspended in compliance with article 9, paragraph 5 of Law no. 03/L-163, unless it is stated otherwise in the notice of the ICMM for the suspension of the license.
- 4. The annual fee is calculated as a calendar year and shall be paid in the beginning of each calendar year in compliance with article 66.B foreseen by article 41 of Law No.04/L-158.
- 4.1. ICMM is obliged to inform licensees or permits holders for payments to be made.
- 5. The annual fee is not paid for the first year when the license is obtained, it is covered by the initial fee, the annual fee is paid with the beginning of the new following year.
- 6. If by the end of the license term it has remained less than 1 year, then the payment of the fee should be divided in proportion to the amount of the fee and the period remained until the end of the license.
- 6.1. When the period remained is less than 1 month, licensees are exempted from annual fees.

Article 8

Administrative fees for execution of monitoring, inspection activities, other services by ICMM.

- 1. ICMM based on law is authorized to collect fees for monitoring, inspection activity and services offered, these fees/tariffs may be for:
 - Request for certification for responsible person, shot firer and explosives trainer;
 - b) Issuance of the responsible person certificates for shot firer, explosives trainer;
 - c) The request for a blasting permit;
 - d) Issuance of a blasting permit;
 - e) Supervision of a blasting.

Article 9 Payment Method

- 1. Payments foreseen by this Administrative Instruction are paid through bank accounts accompanied with the documents that are submitted to the ICMM.
- 2. Revenues executed from paying fees in compliance with Law no. 03/L-163 on Mines and Minerals and this Administrative Instruction are "revenue dedicated" to ICMM and are deposited to the Budget of the Republic of Kosovo.

Article 10 List of administrative fees and their amounts.

- 1. List of administrative fees where it is foreseen the amount of all types of administrative fees is determined based on the group of minerals and required service as it is foreseen by Law no. 03/L-163 on Mines and Minerals (amended by Law No.04/L-158).
- 2. List of administrative fees No.2170 dated 26.03.2014 is attached as an annex to this Administrative Instruction.

Transitional provisions

- 1. This Administrative Instruction shall enter into force 8 days after its publication in the Official Gazette of the Republic of Kosovo.
- 2. Upon the entry into force of this Administrative Instruction, it is abrogated the decision on administrative fees No.2170 dated 26.03.2014.
